



## REDIS GAME DAY CONTEST

### TERMS AND CONDITIONS

NO PURCHASE OR PAYMENT NECESSARY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The Redis Game Day Contest promotion (the “**Contest**”) is sponsored by Redis Inc. (“**Redis**”) in connection with Google Cloud. By participating in this Contest, you agree to these Contest terms and conditions (“**Contest Terms**”). Redis is giving one (1) \$100 gift card, and five (5) \$50 gift cards (each, a “**Gift Card**”) to the top six ranked Participants (as defined below) subject to the following Contest Terms. Participants may play each of the four (4) Redis labs up to five (5) times.

**Only 1,000 Participants spots are available worldwide.** The Contest begins on February 14<sup>th</sup>, 2024, and ends on February 16<sup>th</sup>, 2024 (the “**Contest Period**”) and is open to any person who meets the following criteria (a “**Participant**”):

1. Is a legal resident of a country other than the following: Afghanistan, Belarus, Benin, Bosnia and Herzegovina, Burkina Faso, Burundi, Ivory Coast, Cabo Verde, Cambodia, Central African Republic, Chad, Comoros, Congo (Congo-Brazzaville), Cuba, Democratic Republic of the Congo, Equatorial Guinea, Eritrea, Guinea, Guinea-Bissau, Haiti, Iran, Iraq, Liberia, Libya, Madagascar, Maldives, Mali, Myanmar (formerly Burma), Nigeria, North Korea, North Macedonia, Russia, Somalia, South Sudan, Sudan, Syria, Timor-Leste, Tunisia, Uganda, Ukraine, Venezuela, Yemen, and Zimbabwe, or any other country or territory that may, from time to time, become subject to U.S. export controls or designated as a country that is subject to a general prohibition on U.S. persons engaging in financial and/or export transactions; or persons on any restricted or prohibited party list maintained by the U.S. Departments of Commerce, State and the Treasury are not eligible to participate in the Promotion.
2. Is twenty-one (21) or older; and
3. Participates in the Redis Game Day Contest and completes the four designated labs during the Contest Period.

The Contest is not open to:

1. Employees, officers, and directors of Redis and its affiliates or subsidiaries, employees of advertising, promotion, or other coordinating agencies, or any other entity involved with or otherwise providing services relating to this Contest, and the immediate family members (parent, child, sibling, domestic partner, or spouse of any of the foregoing) and persons living in the same household of such individuals, whether related or not;
2. Employees of government agencies and government-affiliated companies or organizations;
3. Persons who work for entities engaged in active negotiations to purchase products and/or services from Redis;
4. Any person whose employee guidelines or policies do not allow participation in promotions of this type or acceptance of promotional gifts or awards; and
5. Any person who uses a robotic, automatic, programmed, or similar entry method or creates additional accounts to complete the labs more than the permitted attempts.

**Limit one (1) Gift Card per Participant.** The top six (6) Participants will be sent the applicable Gift Card (including the relevant redemption code) within thirty (30) days of participating in the Contest. In addition, the top-ranked Participant will receive a swag package of Redis gear sent to the address provided by the Contestant. Winning Participants are responsible for ensuring the email address on file



with Redis is valid and current in order to receive the Gift Card via email. Participants agree to provide any additional information as may be required to deliver the Gift Card. All Gift Cards are subject to availability consistent with these Contest Terms. Redis reserves the right to substitute an alternative award, in whole or in part, of equal or greater monetary value if the Gift Card cannot be provided as described for any reason, including without limitation, if a Gift Card is not redeemable in an eligible Participant's country of residence.

By participating in the Contest, you represent and warrant that you have obtained any required approvals to participate in the Contest and receive a Gift Card (e.g., from an employer), and your acceptance of the Gift Card is at your sole discretion.

All Participants are responsible for compliance with any applicable federal, state, or local laws, rules and regulations, contractual limitations and/or office policies, if any, regarding participation in trade promotions or acceptance of promotional gifts. Loss or damage is foreseeable if they were an obvious consequence of Redis' breach or if they were contemplated by you and the promoter at the time that you entered the Contest.
